Paralegals Discovery. Circumstantial Evidence: indirect evidence that does not establish the fact regardless if believed or not. Only identifies the likelihood of fact. Authentication Evidence: the process of fortifying an item that is to be introduced as evidence during the trial.

In large organizations, paralegals may work on a particular phase of a case, rather than handling a case from beginning to end. For example, paralegals may only review legal material for internal use, maintain reference files, conduct research for lawyers, or collect and organize evidence for hearings.
