The HUD have issued guidelines for lawn maintenance, as follows: Grass should be cut every two weeks between April and October unless the climate of the area dictates that the grass is cut more frequently. This is indicated by the chart below. Grass should not be cut between November and March unless prior written approval is obtained.
